

Installation

1. Mount speaker to bracket:

- Remove three (3) bolts from back of D-44 speaker. (SEE FIG.2)
- Apply thread locker to threads.
- Speaker wires must exit bottom of speaker (SEE FIG.1)
- Align holes in bracket to speaker and re-install bolts.
- Torque bolts to 30 in-lbs.

2. Remove fog light or filler panel:

- Remove 3 bolts for filler panel or fog light.
- The speaker will be mounted in its place.
- Remove 2 plastic push rivets from frame.
- Mounting studs will insert in this location.

3. Install Cyclone Speaker:

- Insert bracket with previously installed speaker.
- Use flat washers and lock nuts provided.
- Torque nuts to ~20 ft-lbs


4. Route wires:

- Route wires so they are not in contact with any sharp or abrasive surface.
- Fasten securely to nearby features.
- Refer to siren installation manual for wiring connections.



<u>IMPORTANT!</u> Speaker must be mounted with drain hole/wiring exit facing down. Failure to do so will void warranty!

Devices should be mounted only in locations listed in SAE standard J1849. Assure clearances before drilling in vehicle.
